Questions? Answers by David Evans

In July's *Review*, under the heading *Questions*, *Questions*, *Questions*, "A. Nonnymouse" requested details of beginner promotions. Great idea. We'd love to get some feedback on that for our next promotion. Meanwhile, here's what happened to Lynne and me.

We started a new, beginner-level club (Footloose Squares) at the beginning of May. We got 31 beginners through the door on the first night and managed to pick up another 5 or 6 before closing off the class. Of those about 30 are still active after 10 weeks, although not all of them come every week. We usually get about 20 or so beginners with, sometimes, a few angels.

It worked this way. We distributed 4000 flyers, placed about 25 posters, did a demonstration, hired a street stall, advertised in the local paper, and issued press releases.

The flyers were a problem. The population in our dance area has a very high content of Asian, Indian and Italian residents and, since these groups are not traditionally square dancers, perhaps more than 75% of them could never have borne fruit.

Most of our dancers were happy to tell us where they'd heard about the square dance. We got 3 from the street stall/demonstration, 5 came from posters, 5 from flyers, and 13 from either newspaper advertising or the story. Another 8 were brought by friends.

We did a lot of things and got just a few people from each. Had we only distributed flyers we'd have ended up with five people.

The local council were very helpful. Having established contact through their annual street festival we made a point of

meeting one or two of their key personnel. One of them placed posters on 12 council notice boards throughout the municipality. It's worth getting to know the people you're dealing with. (They recently booked us to "perform" on centre stage next March with a view to involving spectators. Guess when our next beginner intake is going to be!)

The newspaper ad bore fruit in its own right but we didn't leave it at that—we sent in a press release on the new club. As luck had it we picked a quiet news week and scored a two-page spread with photographs—and I'd hate to have to pay for that. But remember, the combined story and ad still only accounted for a little over a third of our dancers.

You don't have to be a literary genius to write a press release. When something is happening with your club send it to your local paper. Try and say something interesting or find a different slant. (Did vou have a Scare Dance for Halloween? Were you like Bluewater Squares and had a "P" night where everybody came dressed as something starting with "P"? Will your club be sending a contingent to the National Convention?) If possible. include a photograph. To an editor it's all news and if you don't send it in you won't get it published. If you have email access a phone call will get the editor's name and email address. And remember. you're actually doing them a favour. If they don't get copy coming into the office they have to write it themselves.

So, A. Nonnymouse, that's how we did it. I'm sure Rosalind would be happy to hear from the rest of the folk out there who have ideas on how to promote. I know I would—so let us learn from your experience.

Continuing Chris & Teri Cantrell aticle

A Brief Bit on Leading:

In addition to the positioning of the arms & hands, a good lead from the man makes clear his intentions to the woman, who then follows. The first ingredient of a good lead is for the man to dance clearly & confidently. Clarity from the man is important, as it enables the woman to detect the speed, direction, and feel of a figure early enough to respond appropriately. Second, leads are a subtle, but clear, communication

coming from the man's body, radiating down his arms, and then to the woman. Thirdly, the man should have "tone" in his arms, using the muscles in the upper arm to keep the arms in position and thus allowing the woman to feel his body movement. Avoid the notorious "spaghetti" (limp arms) and the "ram rod" arms (arms held too stiffly and generally with a straight elbow). The woman should not try to anticipate the man's intentions, but should wait to accept & follow the man's lead.

It would have worked a treat except that I was dancing behind Dorothy Ranger at the time and she was holding her flag as she danced. The problem was that it didn't point forward and back—it twirled round and round as she followed the cues and I couldn't take my eyes off it. It was lots of fun on the night but, long term, I don't think it helped my problem much. So if you're dancing around the traps over the next few months and you see me struggling around the floor, don't just laugh, pull on a red arm band.

Or if you don't have one you might just share a kind word with Daizy. She has a lot to put up with.

Australian National Square Dance Convention Advisory Board

Notice of Motions for Amendments to the Operations Manual

The following amendments to the Operations Manual for Running National Conventions were passed by the appropriate majority at the Annual General Meeting held in Tamworth on 10th June 2001. They are now in accordance with Constitution clauses 16.06(b) and (c), publicised and will be listed as Special Business at the Extraordinary General Meeting to be held in Mandurah on 12th Sept 2002.

M1 Section 103.9(a) - The parking area should be large enough to accommodate cars on the basis of 1 for every 3 delegates. If sufficient space is not available, alternative arrangements for parking should be considered.

M2 Section 106.8 - Delete. **M3 Sections 102.1 and 107.9** (b) - Renumber existing 102.1 as 102.1 (a) 102.1 (b) - After acceptance of a bid, the details of the Convention should be confirmed in writing to the proprietors of the Venue and written acknowledgment received from them.

Delete 107.9 (b) and renumber 107.9 (a) accordingly.

M4 Section 109.6 (b) - If the committee is able and willing to do its own catering for the provision of continuous tea and coffee during sessions, guidance as to appropriate quantities is given in an appendix.

M5 Section 111.4 (c) - Delete. **M6 Section 114.1** (b) - In general the level shall be the Mainstream Program. However the Committee should be aware that increasing numbers of delegates are also able, and may prefer, to dance to higher Programs such as Plus, A1 and A2 during daytime sessions.

M7 Section 115.4 (b) - A Couples Roundup should be conducted in the same manner as a Singles Roundup except the four dancers across would be in couples.

M8 Section 115.9 In the Convention Hall general dancing sessions, it is recommended there should be at least two Square Dance Brackets to one bracket of associated type dancing.

M9 Section 116.04 (c) (ii) - The Round Dances should be selected from the current "Main" and, Supplementary and Callers List sections of the current Australian National Round Dance Convention list.

M10 Section 116.04 (d) (ii) - Complete guidelines for this session are listed in the Australian Round Dance Manual Section 9. A copy is available from the Australian Round Dance Association.

M11 Section 116.07 (a) - Any Round dance cuer wishing to cue at a Convention shall indicate this intention in the box provided on the Convention registration Form. Sections 116.07(b) and 116.07 (c) - Delete. Section 116.07 (d) - It is recommended that the closing date for receiving applications to cue should be six months prior to the Convention. Renumber sections 116.07 (d) to (h) accordingly.

M12 Section 116.07 (h) - withdrawn M13 Section 116.08 16.08 (f) - The selected Round Dance Representative shall advise the Australian Round Dance Association Executive of the dances which have been nomininated for the Showcase. Voting slips will then be made available by the Australian Round Dance Association to the Convention Commit

-tee. The administration of the voting held at the Main Round Dance Session shall be conducted by Members of the Australian Round Dance Association Management Committee or their proxies. **New sub-section 116.08** (g) - Should any State or Territory recognised by the Australian National Square Dance Convention Constitution not present a Showcase then the Management Committee of the Australian Round Dance Association should be contacted and they be empowered to nominate a dance to fill this vacancy if they feel it is necessary. It will be the responsibility of the Executive of the Australian Round Dance Association to organise and fulfil the necessary requirements of this Showcase presentation.

M14 Section 116.14 (a) - A suitable hall of adequate size shall be made available for the Clogging session(s). M15 Section 117.8 (b) - It shall be accurately timed.

M16 Section 117.9 (b) - Special Announcements and/or Presentations shall be made when only the Convention Hall is being used.

M17 Section 120.1 (b) - Where it is patently obvious a delegate is unable to dance the stated Program, the Committee shall approach the person in question and request his or her non-participation. If the offender persists, he/she is to be asked to surrender his or her Convention badge and leave the dance floor.

M18 Section 121.3 (e) - The Australian Callers Federation shall supply to the Convention Committee a printout of all callers registered in the Australian Callers Database showing each caller's eligibility to call for the various dance programs and the year when information was last updated. All caller associations should remind their members that it is each member's responsibility to ensure that their database entry is correct. Callers, wishing to call at the Convention, who have no database entry would have to furnish proof to the Convention Committee that they do in fact meet the eligibility criteria contained in clause 121.1. The Convention Committee shall then validate this through the Australian Callers Federation.

M19 Section 127.3 (d) Delete M20 Section 128.5 - Dancers should be encouraged to wear their local club name badge at all dance sessions and meetings.

M21 Section 129.2 (a) Appropriate stationery shall be produced for the Convention (b) All correspondence from the Committee shall be on letterhead which shall state the post office box number and the names, addresses and telephone numbers of office bearers, sufficient for people to contact the appropriate person.

M22 Section 129.3 Delete **M23 Section 131.2** - The Insurance policies shall specifically insure the whole of the Convention for a minimum public risk of \$10,000,000 (ten million dollars) or such larger amount as is required by the venue owners.

M24 Section 132.7 (c) Invited Dancers should be appropriately attired and it is suggested that Square Dance attire is appropriate.

If you have any comments on of the above proposed amendments to the Operations Manual, please put them in writing to the Secretary (Anthea Matthews 18 Sinai Place, LOCKRIDGE W A 6054) before 15 August 2002, and they will be considered at the next Advisory Board meeting. Should you wish to make any comments, it would be preferable if you were to discuss them with a Board Member before submission.
